### Public Protection Committee what is it?

The PPC is a multi agency partnership responsible for the strategic oversight and delivery of services to our most vulnerable population across Dumfries and Galloway. The committee is represented by senior managers from the NHS, Police Scotland Social Work Services, Education, Voluntary and Independent sectors, and other key partners

The chief officers group leads the partnership and has a responsibility for and oversight of Public Protection and the appropriate implementation of agreed structures. The

group will ensure there is a multi agency commitment to collaborative working across the public protection through engagement with all relevant agencies This allows for a much greater information sharing and networking and deducing duplication.

It is fully appreciated that the PPC cannot deliver on the agenda on its own and will continue to build stronger links between South West Scotland multi agency public protection arrangements (MAPPA) Alcohol and Drug Partnership and the Community Justice Partnership.

### The Communication and Engagement Sub committee what is it?

The C&E group directly reports to the public protection committee the group was established to take forward the National priority around developing a clearer understanding of service users and their carers views in relation to public protection issues process.

This should allow us to increase our understanding of public protection processes and how services can better involve them in the planning and redesign of support at a local level.

# **County Lines**

Vulnerable individuals are being exploited by gangs involved in drug crime.



Crime stoppers has seen a 600% rise in Scottish county lines-related calls from January – September 2019 compared to the same period in 2018 (BBC Scotland Oct 2019)

### Know the signs to spot.

County lines drug trafficking. In the United Kingdom county lines drug trafficking is the practice of trafficking drugs into rural areas and smaller towns such as Dumfries away from major cities to make more money. This can have a negative effect on the community that live there. Gangs recruit children, young people, and vulnerable adults, often using social media, they bully scare and or intimidate sometimes physically sexually and financially, whilst using their homes as bases.

### Identify some signs

- Not being seen
- Anti- social behaviour
- Drug paraphernalia in and around property
- People calling at different times day and night



**Cuckooing** is when drug gangs take over the home of a vulnerable person through violence and intimidation, using it as their base for selling/ manufacturing drugs.



### Child Sexual Exploitation – progress made but more needs done

### Barnardo's Scotland blog

In October Scottish Children's Reporter Administration (SCRA) and Barnardo's Scotland launched the findings of the first ever nation-wide study on Child Sexual Exploitation (CSE) carried out over the last two years.

Please find the Policy paper, **Policy Report: Sexual exploitation of children involved in the Children's Hearings System**, and 15 recommendations, based on the key findings from the joint research, for action by a variety of organisations across Scotland.

Participation work with children and young people who access Barnardo's Scotland sexual exploitation services tell us that their experience of decision-making about them is often negative. They have expressed their frustration at having to repeat their story multiple times and explained how disempowering it is to learn of meetings and investigations that have taken place "behind your back". They have reported that they are aware of victim-blaming attitudes within these systems and how the experience can cause deterioration in their wellbeing, which impacts on their relationships with trusted adults. In fact, some young people have explained how these processes have felt as coercive, traumatising and isolating as the exploitative situation they should be being protected from.

### **RESPECT ME**

Dumfries and Galloway Council's strong partnership with **respectme Scotland's Anti-Bullying Service** is long-established and mutually highly valued, so when respectme were seeking to pilot their innovative 'respectme reward' programme we welcomed the challenge.

A key finding from the recent external review of respectme identified that stakeholders wanted to see a greater emphasis on how anti-bullying policy resonates with daily practice.

Dumfries and Galloway Council shares respectme's vision of a respecting, just, equal, and inclusive Scotland in which all children and young people can live free from bullying and harassment and are encouraged to reach their full potential. By advancing and respecting Children's Rights, the authority strives to help them feel safe and enjoy a sense of belonging in settings, with health, wellbeing and positive relationships being central and essential to their experience.

We are working alongside respectme to support schools and services to evidence the impact and outcomes of their anti-bullying work, to find and share excellent practice.





### Why a chronology should be the first thing you do in an assessment!

### Why do a chronology first!

Chronologies are an essential part of any good assessment, a vital foundation for analysis, and a tool to help practitioners develop rapport with service users. A chronology is the start, and heart, of a good assessment and provides a key link "like the pieces in a jigsaw" to understanding risk and protection from harm. The setting out of key events in sequential date order, provide a summary and timeline of a child, young person or adults circumstances, patterns of behaviour and lifestyle that assist assessment and analysis. This allows a logical, methodical, and systematic means of organising, merging, and helping make sense of information and joining key information together.

We have sourced the ten-minute animation produced by the West of Scotland Child Protection Consortium. While originally designed for children's services, it applies to all ages and service areas. We hope you will find it helpful to your understanding and application of chronologies in your practice.
